
### Important Information

- Medical Expenses claims are subject to an excess of €50 each and every claim or 10% of the total expenses incurred whichever is the greater.
- Physiotherapy expenses certified by a Medical Practitioner are included in Medical Expenses cover up to a limit of €250 per Insured Person per claim.

- Medical Expenses are payable for 12 months from the date of the first treatment. Only irrecoverable Medical Expenses are covered.
- If an Insured Person has medical health insurance or other covers, claims for Medical Expenses must firstly be pursued under that policy before this policy provides.
- Cover for emergency dental treatment is included in Medical Expenses cover up to a limit of €1000 per Insured Person with €100 excess  
Attendance at the dentist must be within 48 hours of the accident necessitating the emergency dental treatment
- All claims must be notified to Arachas within 30 days of the accident causing the Bodily Injury. Any claim notified more than 60 days after the date of the accident will not be covered. A fully completed claim form and any accompanying documentation must be provided to Arachas promptly, this will also allow Arachas to arrange for any interim payments to be made if necessary. Claims cannot be processed if documentation is incomplete or outstanding.
