Summary of Cover

1<sup>st</sup> of December 2025 to 31<sup>st</sup> of July 2026

- **Cover only applies to Registered Officials who have received an ID number by the DDSL and assigned by your club to a team panel**
- **Please refer to Policy Document for full details of cover including all terms and conditions applicable**
- **Effective date of cover is when the Registered Official is added to a club team panel by his/her club**



## **Personal Accident Cover:**

### **What is personal accident insurance?**

Personal Accident Insurance covers all registered Club Officials such as, Managers/Coaches of clubs in the DDSL, (registered to Team Panels), for a range of benefits payable in the event of an Accidental Death or Bodily injury whilst playing football, training and travelling for your club.

### **Who are the insured persons under this policy?**

This policy covers all DDSL Registered Club Officials, who are registered on the DDSL fusion system by their club. No cover is provided for anyone, if they are not registered with DDSL at the time of an accident. Cover only applies from the date of registration/purchase of cover on the DDSL's Manager/Coaches on line fusion system.

### **What activities are covered?**

As stated, this policy provides cover for registered Club Officials, Managers/Coaches while participating in any official training sessions or games sponsored, organised or supervised by DDSL and their clubs including friendlies, matches abroad and inter-league competitions, as well as clubs own events approved by the DDSL.

### **Who is my insurer?**

Aviva Insurance Ireland DAC. Arachas act as your broker for the purpose of this policy.

### **What are the key benefits?**

Death:	€25,000
Permanent Disablement:	€80,000
Medical Expenses:	€10,000
Emergency Dental:	€1,000
Physiotherapy:	€250 per official per injury
Excess:	€50 or 10% of total claims for Medical
	€100 excess per claim for Dental

### Claims Handling (IMPORTANT)

- Please note your private health insurer or other policies are the first port of call and this policy only caters for Medical Expenses which are irrecoverable elsewhere. Cover is provided for limited Physiotherapy Expenses where there is a requirement for same pre or post-surgery. All policies must be used first before this section is operative.
- You must be a registered official of the DDSL with a member number issued by the DDSL and allocated to a Team Panel by your Club
